Dear Sirs/Madam,

I am the defendant in this action. Please bring this email urgently to the attention of Madam Prothonotary Tabib.

In view of the expected avalanche of letters from Mr Gray to the Court, I am compelled to answer briefly as follow.

According to Mr Sachedina - the affiant of Mr Gray - His Highness had already previously read my letter of 4th January which was snatched from his hand during discovery. This was not a new document. Mr Gray has confirmed my questions for all to see that all of the 5 questions I intended to ask were related to this letter.

Mr Gray is a senior lawyer, he has drummed to the Court several times about his integrity by been "an officer of the Court" but he has himself attempted to transform the Discovery of His Highness into a discovery of the un-sworned, unrepresented defendant Tajdin [myself]. As to his denying of bullying, the one pager transcript he has produced is self explanatory.

Mr Jiwa is not my lawyer and as such should not have to and did not intervene. By doing so he also respected his commitment to attend discovery as observer, not as participant. This is to his credit.

I will object that whatever has been proposed by me in good faith in the context of a Consent Judgment should be now misused in the context of the Motions.

I have tried my best to convince Mr Gray to tell me which sentences from the Consent he would like modified but my request has fallen into deaf ears [attached email] and Mr Gray adamantly want to go for more Motions against the expressed wishes of His Highness.

I believe I have legally no choice but to be dragged, by Mr Gray, into the forthcoming Motions. I am therefore confirming to the Court that

I am making again travel arrangements from Kenya to Toronto for the Motions to be heard on 7th of December 2010.

Dear Mr. Gray,

I understand that you found my previous letter strongly worded. However, the Aga Khan wants this matter put to rest with a consent judgment.

I therefore suggest that we put aside our differences and work together to close the file.

As you can see I have included in the consent judgment all of the 4 main points mentioned by His Highness, together with 3 of His suggestions and 1 of His acknowledgement.

I suggest you to review my signed "consent judgment" in this collaborative spirit.

If you believe that some statements in the document I have signed could be better formulated or should be modified, please let me know and I will reconsider these sentences so that the wordings are acceptable to both parties. In particular I am willing to add the following statements of His Highness, which I have omitted from the Consent, because I was not sure they are relevant to the Consent at this point in time:

- a) That His Highness said that he wanted to meet us again.
- b) That Farmans of the past Imams are His own.
- c) That it is the responsibility of the Imam of The Time to protect the Farmans and the Ginans.

d) That His Highness was not familiar with any issues with my web site

e) That His Highness told Mr Manji to work with me for the web site - I am not sure why Mr Manji and Mr Sachedina were present at the half hour Discovery?

If you further desire that the term of the Consent remain confidential, I am also agreeable to this.

I hope that by forgetting past frustrations and by working together we will be able to close very quickly this file to the satisfaction of His Highness and within the scope of His instructions and statements during the discovery.
